### Timetable Planning Rules

The above example standard hour timetable is based on timetable modelling work undertaken to date and is not a final timetable.

As part of the infrastructure changes, the Timetable Planning Rules will require alteration and additions. The train planning rules will be developed jointly between GWR/NR and North Somerset and will be consulted via Part D of the Network Code.

The Timetable modelling undertaken to date is based around the Dec 2019 timetable and includes the enhanced GWR service plan and the extension of CrossCountry services to Exeter.
