## 1. INTRODUCTION

- 1.1 This document provides a guide to North Somerset District Council's (**Applicant**) Development Consent Order (**DCO**) application for the Portishead Branch Line (MetroWest Phase 1) (**DCO Scheme**).
- 1.2 This is a live document. The master documents list (Schedule 1) will be updated when updates or revisions to existing documents are made and new documents are submitted to the Planning Inspectorate. Updates will specify which version of the relevant listed document is the most up to date.

## 2. MASTER DOCUMENTS LIST

2.3 The table attached at Schedule 1 is the **Master Documents List**. It identifies the documents produced for submission. Document List identifies the part, title, submission date and version of the document.

- 2.4 Some documents are duplicated within the Master Document List. The purpose of this duplication is to allow the Planning Inspectorate and members of the public to find key documents that are likely to be updated during examination or that are referred to a number of times.
- 2.5 The version of the document contained within the ES will not be updated during examination and will be endorsed to show that it is a record of the document at the time of submission. The separately numbered document will also be endorsed, so that it is clear it is the latest version, should any updates be made during examination.
